## Calculating Monthly Rental Rates

Rates expressed are percentages of invoice price (including GST). The calculated rental cost will be inclusive of GST & stamp duty. Always round up monthly rates to the next dollar amount.

### Example

A \$8,000 deal over 36 months  
 $\$8,000 \times 3.71\% = \$297.00$  per month

### The Residual

Multiply the invoice price (total inc GST)  
 by 15% = \$1200 (inc GST)

### Equipment Protection Plan (optional)

Add 7% to monthly payment  
 $\$297 \times 7\% = \$20.79$   
 Total monthly payments = \$317.79 (inc GST)

### GST

For GST input credit purposes, the customer  
 would receive a GST invoice showing:  
 $36 \text{ (payments)} \times \$28.89 \text{ (10\% GST on payments)}$   
 = \$1040.04
